## VTA/DOT UPDATES FOR MARCH MEETING

The Sherman Oaks Neighborhood Association requested a response in March response from the employees of Valley Transportation Authority(VTA) and Department of Traffic (DOT) concerning three specific issues: (1) Soundwall height along the new lightrail corridor on Southwest Expressway, (2) Improvement of the Fruitdale/Southwest/Corlista exchange to help traffic flow and reduce current problems of cut through traffic and traffic snarls due to the bus stop (3) Pedestrian access at the major intersections of Fruitdale/Southwest and Leigh/Southwest. There were public meetings recently on these issues.

The Corlista/Fruitdale/Southwest area is currently undergoing a design modification to address some of the issues there. An outline of the design change and solutions to the problems will be presented.

Resident Robbie McGuinness has been active in contacting departments concerning the Southwest Expressway soundwall. Councilman Ken Yeager has joined us in expressing concerns about the soundwall. Results of recent community meetings and VTA studies will be presented at the March meeting.

Our March meeting will include time to determine what you want SONA's goals to be for 2003. Do you want to focus on traffic and pedestrian access? Do you want to see more clean ups? **BOARD ACTIVITIES**

The SONA board is always active in many things, often behind the scenes. For instance, recent meetings between city officials and residents concerning traffic issues was coordinated by Board member Charles Crowder.

The Board is actively engaged with San Jose City College in ongoing discussions concerning soundwalls, traffic and noise. Board members are monitoring local landlords to assure compliance with code enforcement and to ensure the reduction in criminal activities. In development is the HiFive program that will encourage neighbors to be keepers of each others emergency information and to watch out for one another.

**WHERE DOES SONA MONEY GO?**

SONA requests a nominal \$12.00 per year contribution to offset the costs of day to day business. We depend on dues and contributions to pay for newsletters, and basics such as snacks for the meetings.

Chairing committees, conducting meetings, maintaining the website and producing the newsletter is only accomplished through hundreds of hours of volunteer time. With the current economic situation we cannot count on grants or outside funding to pay for these things.

**PROPOSED BYLAWS CHANGE**

A proposal for a change in the bylaws has been submitted to the Board of Directors and is being presented to the general membership at the March 2003 general meeting for vote.

The proposed changes are:

Article V, Section 2 (c) (1) currently reads: Provide the membership with a slate of nominees for all elective positions in the Notice of the Annual March Meeting. Proposed change would be "...Annual April Meeting..." to comply with our calendar as set last year.

Article VII, Section (5) (a) currently reads: The Board shall meet at least once a month on the last Tuesday of the month. Proposed change would be "...on the fourth (4th) Tuesday ..." to ensure timeliness of Board meetings.

**SONA DONATION**

At the recent general meeting SONA was presented with a general outline of the Sherman Oaks Soccer Club (SOSC). Sherman Oaks Charter School teacher and SOSC coach Osvaldo Rubio has dedicated countless hours to developing a soccer club at the school.

The club formed 6-7 years ago with only two teams. The club has grown to 10 teams of local children who have developed quite a reputation in the district as teams to be reckoned with. Former members of the club have participated in state and national championships as well as Olympic feeder teams. Several have gone on to professional careers including one former player who was recruited at the age of 15 for the Mexico team.

Because many children in the area come from low income families, funding for the teams and their equipment has often relied on outside sources. Mr. Rubio has often paid the soccer league fees himself. This year, the team found itself short of funds for 10 students.

Resident Marge Waggoner put forth a motion to fund these children for this year to the tune of \$750.00. SONA was able to write a check that evening to the soccer club. If anyone is interested in donating to the club or in assisting in club activities, contact Osvaldo Rubio at the school. Future game schedules and the annual celebration event will be posted at a later date.

**NOTICE OF ANNUAL MEETING AND ELECTIONS**

The annual meeting and election of officers will take place in April. Any member is welcome to apply for a Board position. Per our bylaws, a nominating committee will handle the nominations. All SONA members are eligible to be on the nominating committee or run for office. If you are interested in either, contact Michael LaRocca, Nominating Committee Chair, at 289-8449. Positions open for nomination are:

**President (1):** Preside at meetings, enforce the bylaws, appoint committee chairs and perform other duties as needed.

**Vice President (1):** Perform duties of President in absence of President, perform duties as Master At Arms during meetings and other duties as needed.

**Communication Vice President (1):** Record minutes of meetings, maintain a copy of bylaws at meetings, prepare ballots for all elections and retain for 30 days after they are cast, prepare grant requests, assure proper notification of association meetings, board meetings and prepare correspondence, oversight of newsletter and website.

**Community Liaison (1):** Maintain membership list, coordinate hospitality events, copy newsletter and ensure delivery, perform other duties as required.

**Treasurer (1):** Holds all funds in trust and maintains association financial records, disburses funds, prepare annual summary of funds, comply with grant regulations and other duties as required.

**Area Captains (5):** Maintain distribution of newsletters in geographic areas, assist in community projects, facilitate communication between residents and association, serve as general members of the board and attend monthly board meetings, collect information concerning crime, problems and potential improvements in area.

**CLEAN UP FUNDS AVAILABLE**

Many of you participated in the SONA-wide community clean up in October 2002. Funds are still available to you if your area needs to have a dumpster day. If you are willing to organize an event with your neighbors, we can provide funding for dumpsters.

The neighborhood clean-up is meant to help the community as a whole and act as a way for your and your neighbors to get rid of accumulated trash and debris. Funds cannot be used for personal home improvement projects. Funds are available to both homeowners and tenants.

If you only have a few items, remember that you can make arrangements to have them picked up on your regular garbage day for a nominal fee.

**COUNCIL DISTRICT 6 REPORT**

Councilman Ken Yeager updated SONA in District 6 events at our February meeting. Mr. Yeager started by commending his aide Debbie Rocha who has been at most of our meetings this last year. He also commended our efforts to clean up Moorpark in January.

While the current budget freeze has halted many projects, Councilman Yeager has turned over \$65,000 from the district's construction and conveyance fund to complete the Buena Vista Park. While this lot is across the freeway, it is easily accessible and will be a service to all surrounding neighborhoods.

While discussions continue with San Jose City College concerning a joint use facility, Ken's staff is also looking at alternatives that could bring services to our area quicker.

There may be a library in our future if ongoing talks progress well. Councilman Yeager is hopeful a decision will be made regarding the library by our March general meeting.

**SHERMAN OAKS COMMUNITY CHARTER SCHOOL UPDATE**

Our February meeting speaker was Peggy Bryan of Sherman Oaks Community Charter School (SOCCS). Peggy outlined how the school was converted to charter school status. Charter schools maintain the same academic criteria while operating without a traditional big book of rules and regulations.

SOCCS is a bilingual Spanish/English immersion program in which all students K-6 are taught in both languages, allowing the student to learn in his or her native tongue while becoming fluent in another. While serving our neighborhood children, this program has attracted students from as far as Morgan Hill.

The current budget crisis has the potential to deplete the staff by one-third. Due to the economic insecurity facing the school, Peggy has postponed her retirement scheduled for this year to see the school through the upcoming changes.

Residents are invited to drop into the school at any time to lend a hand or just take a look around. You'll find children actively engaged with materials in two languages, a clean and orderly campus and the strong feeling of a community school.
