
Prizes will be given out for people in different categories like "Newest Resident" and "Longest Resident". If you have never been to a SONA meeting, this is your chance.

UPDATE ON THE CITYWIDE TRAILS SYSTEM

Dear Fellow Trails Enthusiast:

I have great news to share regarding further development of the citywide trails system.

On June 24, 2002, the City Council approved the request for \$1 million to augment the City's efforts in acquiring the Union Pacific Railroad's Willow Glen Spur Line from Coe Avenue to Minnesota Street. The City Manager will now negotiate with

the Santa Clara County Open Space Authority to acquire the funds. While we still have to raise additional money, yesterday's decision marks an important percentage of that.

By authorizing the use of the 20 percent open space-funding program from the Santa Clara County Open Space Authority, the Council has taken an important step towards securing a significant amount of property to dedicate towards establishing trails. This piece of property will provide an important East-West connection to three of our most popular trails: the Los Gatos Creek Trail, the Guadalupe River Trail, and the Coyote Creek Trail. Aside from this stretch of abandoned Union Pacific rail line, there are no other off-street opportunities to make this connection in the central part of the City.



To date, \$4.8 million has been designated to purchase the Willow Glen Spur with the potential of an additional \$2 million from Santa Clara County. Because of the hard work and support of County Supervisor Blanca Alvarado, we are closer than ever to making the Willow Glen Spur Trail a reality. Her commitment to this project and her generous allocation of time and resources for this cause deserve much appreciation. A tremendous thank you to Supervisor Alvarado.

Moreover, at the same Council meeting, the City Council accepted a \$500,000 grant for pedestrian/bicycle corridors. The California State Department of Transportation grant provides federal funds for the purpose of constructing a bicycle and pedestrian trail within the Guadalupe River Park between Santa Clara Street and the Union Pacific Railroad tracks south of Coleman Avenue. Slated to be open for public use in the summer of 2005, this half-mile segment is crucial to completing the 2.6 mile trail linking the airport to downtown.

Because hiking, biking, running and walking are among the most popular activities in San Jose, I am committed to building trails and enhancing the ones we already have.




